# **Vending Fees**

10x10 Booth Fee - Full Season - \$585.00

10x20 Booth Fee - Full Season - \$975.00

10x10 Booth Fee - Daily - \$45

10x20 Booth Fee - Daily - \$75

10x30 Booth Pricing - Contact Market Coordinator.

Veteran Discounts - For Returning Market Vendors - Subtract 10% from booth fee.

Early Payment Discount - Full Season Payment by May 1st - Subtract 5% from booth fee.

# **Vendor Promotions**

Vendors have the opportunity to submit a promotion for the coming weekend by the Tuesday previous and have that promotion posted on the <a href="www.nwxfarmersmarket.com">www.nwxfarmersmarket.com</a> website, and in weekly market email blasts that are distributed to 700+ recipients.

Vendors will be promoted through multiple channels for the duration of the market season including: print advertising, posters, the C3 Events website, the NWX Farmers Market website, weekly market email blast and additional social media.

### Vendor Check-In

NorthWest Crossing Saturday Market Location: NorthWest Crossing Drive between Mt. Washington and John Fremont St. will be closed off for Market (center of NorthWest Crossing Neighborhood Center).

2014 Event Season - June 28<sup>th</sup> - September 20<sup>th</sup> (Saturdays)

Event Hours: 10am-2pm

Set-up: 7:30 a.m. - 9:15 a.m. (Set up should be completed by 9:15 a.m.)

Market vendors are responsible for their own 10 x10 tents, tables, chairs and weights for the tent legs (secured weights for each tent pole are required).

Market vendors will enter the NorthWest Crossing neighborhood from Mt. Washington, on Ordway Avenue and take an immediate right onto Fort Clatsop. The check in will be at the intersection of Northwest Crossing Drive and Fort Clatsop. Vendors will receive their booth numbers and will be able to unload their booth infrastructure, equipment, product, and then immediately park their vehicles in the designated vendor parking areas. Main parking area is the dirt lot that is located on the west side of Mt. Washington Drive, across the street from The Garner Group Real Estate office. Other available parking is along John Fremont Street. Please leave business parking lots in NorthWest Crossing open for neighborhood businesses and market attendees.

### Tear Down

Tear down commences at 2pm. Vendors may retrieve their vehicles after that time and enter Northwest Crossing Drive. We ask that as much of the tear down occurs before you pull up the vehicle to make the loading and exit process efficient. We want everyone to be able to load up and exit in a timely manner.

### Other logistics

If vendors have left over product that they do not wish to take with them, a representative from Bend Community Center or NeighborImpact local food bank will be on-site to receive your charitable donation.

# Market Policies

# RSVP:

Market vendors need to confirm their attendance each week by the Tuesday before the market. Please note that we will expect you to participate in the market for the dates you commit to. There are no refunds for any reason. The success of our market depends solely on the market vendors providing consistency with their availability and product each week. Noshows may lose their regular booth location at the market, and after two no-shows, regardless of payment plan, vendor will be required to pay a \$30 re-entry fee. We require at least four (4) business days notice if you are not able to participate on a Saturday that you have committed to previously. Thank you for your support. Vendors on the Daily Plan for booth fees are responsible for bringing fee to check in. Checks are to be made payable to West Bend Company. ### TRASH:

Market vendors are responsible for bringing their own trash off the event site each week. Please bring trash receptacles with you for your booths if necessary.

### **ELECTRICITY:**

There is no electricity <u>guaranteed</u> for market vendors; however, there are opportunities to plug-in and utilize electrical access points. Vendors need to coordinate any electrical needs with the market coordinator ahead of the market weekend.

## INSURANCE, LICENSES, CERTIFICATIONS:

It is the sole responsibility of the vendor to secure all necessary licenses and certifications to be eligible to sell at the NorthWest Crossing Saturday Farmers Market. The Oregon Department of Agriculture and Deschutes County agencies require these licenses to be in good, visible display at all times during your stay at the Market. Please keep your licenses, certifications and application current. You are responsible for bringing license copies to each market.

The Market does not assume responsibility for general or product liability insurance. All vendors are required to purchase general liability insurance of \$1 million dollars and must provide a copy of the Certificate of Insurance listing C3 Events and West Bend Property Company as additional insured organizations in order to participate in the Market.

In addition, those vendors who sell <u>consumable products are required to purchase product</u> <u>liability insurance</u> of at least \$1 million dollars and must provide a copy of the Certificate of Insurance listing C3 Events and West Bend Property Company as additional insured organizations in order to participate in the Market.
